# 1 RULES

- **1.1** The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- **1.2** The Yachting New Zealand Safety Regulations Part 1 shall apply.
- **1.3** The Tauranga Cup Rules and Conditions will apply (www.yacht.org.nz).
- **1.4** Appendix T, Arbitration will apply.

#### 2 SAILING INSTRUCTIONS

The sailing instructions will be available after 1700hr on 8<sup>th</sup> December 2023 on the TYPBC website (www.yacht.org.nz).

# **3 COMMUNICATION**

[DP] Except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

**3.2** The official noticeboard is located in the lower floor of the TYPBC next to the race office.

#### 4 ELIGIBILITY AND ENTRY

- **4.1** The event is open to all boats of the P Class that comply with the class rules and have a current P Class Register Certificate in the name of the current owner.
- 4.2 Eligible boats may enter by opening this link. https://forms.gle/y94GCVybHm45mvSd9
- **4.3** To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.4 Entries are to be received online by 0900hr Tuesday 19<sup>th</sup> December 2023. NO Late entries will be accepted.
- **4.5** To be eligible to compete in this event each competitor shall be a financial member of a club recognised by the competitor's national authority.
- **4.6** Each competitor, shall be, under the age of 17 years on the 31<sup>st</sup> January 2024.
- **4.7** The following documents must be provided no later than at completion of registration:
  - (a) Proof of yacht club membership,
  - (b) Proof of current P Class Registration,
  - (c) Proof of competitor's DOB.

- **7.6** The scheduled time of the warning signal for the Centenary Trophy Race is 1355hr.
- 7.7 The scheduled time of the warning signal for the first race each day is1055hr.
- **7.8** On the last scheduled day of racing no warning signal will be made 1500hr.

# **8 EQUIPMENT INSPECTION**

- **8.1** [DP] Boats shall be available for equipment inspection Saturday 6<sup>th</sup> January 2024 10.00hr 1300hr.
- **8.2** Boats may be inspected at any time.
- **8.3** [DP] Boats shall also comply with RRS 78.1at all times while racing.

# 9 VENUE

- **9.1** Is the Tauranga Yacht & Power Boat Club (Inc), at the end of Sulphur Point Tauranga.
- **9.2** The races will be held within the confines of the Tauranga Harbour.

# 10 COURSES

The courses to be sailed will be windward/leeward or triangle, Windward/leeward.

# 11 PENALTY SYSTEM

**11.1** Appendix P will apply.

**11.2** For the P class RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

# 12 SCORING

- **12.1** 5 races are required to be completed to constitute a series.
- **12.2** (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
- (b) When from 5 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- (c) When 9 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

#### 13 SUPPORT PERSON VESSELS

- **13.1** [DP] Support boats are permitted but their movements may be restricted.
- **13.2** [DP] Support boats and the person in charge must be registered with the Organising Authority at Registration.
- **13.3** [DP] All support person vessels shall always have an engine safety cut out switch (kill cord) attached to the driver while the engine is running unless prior written exemption has been provided by the Organising Authority.

#### 14 LAUNCHING

[DP] Unless otherwise directed by the Organising Authority, all competing boats and equipment shall be launched and retrieved from in front of the TYPBC.

# 15 RISK STATEMENT

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

# 16 INSURANCE

**16.1** Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 per incident or the equivalent. Certificate of insurance is to be presented at registration.

**16.2** Support boats if they wish to enter the marina, MUST have insurance as described in 16.1 and a Certificate of insurance is to be presented at registration.

**17.1** Prizes will be given as follows:

• The Centenary Trophy -Winner of the Centenary Trophy Race

The Tauranga Cup - Highest ranked sailor in the overall results

The Memorial Cup - Second place in the overall results

The Carter Cup - Third place in the overall results

 The Naomi James Challenge Trophy - Highest place Female sailor in the overall results

• The Harken Trophy - Second placed female sailor in the overall

results

• The Harry Highet Salver - Winner of race 1

• The Murrays Bay Cup - Highest placed first-time competitor

• The Farr & Associates Trophy - Youngest competitor in the top ten overall results

The Franklin Plumbing Trophy - Awarded to the Club of the Tauranga Cup Winner

The Colin Smith Trophy - Highest placed sailor from the Host Club

• The Craig Monk Trophy - Highest placed sailor over 55kg

**17.2** Other Prizes may be awarded at the discretion of the Class Association or the Organising Authority
